March is Women's History Month in which we celebrate the achievements of amazing women throughout history. It seems fitting that the speaker for our March 20 branch meeting is a local trailblazing woman, Jane Gill Watt.

Jane is the founding member and past president of Impact100 SRQ, a 501 (c)(3) nonprofit that has awarded \$2.4 million dollars to 22 local nonprofit organizations since its inception in 2018. With over 700

members and counting, **Impact100 SRQ** is the fastest growing Impact100 chapter and joins more than 70 chapters worldwide who have embraced the power of collective giving.

Jane was raised in a small town in upstate New York before attending Radford University in Southern Virginia. Her career and family led her to Indiana, where she worked in the pharmaceutical industry, focusing on the oncology sector, before relocating to sunny Sarasota. After learning about the Impact100 model from her mom and sister, Jane took a sabbatical from her career, serving as founder of Impact100 SRQ, which ignited Jane's passion for making a positive change in our community.

You won't want to miss hearing more about Jane and Impact100 SRQ, which has harnessed the power of women to solve problems and affect meaningful and sustainable change by awarding game-changing grants within Sarasota and Manatee counties.

The AAUW Florida Public Policy Committee has selected six bills to support and one to oppose for the current legislative session that began January 9. You may not read about these bills in the news, but they have been crafted to make the lives of women easier in Florida. Please contact your state legislators to give your opinion–position papers are available on the AAUW Florida website: <a href="https://aauwadvocacyflorida.blog/2024/01/10/florida-2024-legislative-session/">https://aauwadvocacyflorida.blog/2024/01/10/florida-2024-legislative-session/</a> After stating that you are a constituent, you may use the AAUW Florida name (I stand with AAUW Florida on this bill.) or just write a short note in support/opposition with your name.

**ERA Bills: SCR142/H647**: The 14th Amendment to the US Constitution does not prohibit discrimination on the basis of sex in the same way it does for race or national origin. We need this protection now.

**Pregnant Women in Custody: SB 100/HB 237**: After a pregnancy test on their request, every arrested female would be allowed to petition for a postponement, but not a reprieve, of incarceration. Jail is no place for healthy pregnancy and delivery.

**Paid Parental Leave for State Career Service Employees: SB 127/HB 128**: This bill changes unpaid to paid leave for the over 80,000 employees of the State of Florida, who are paid an average of \$56,500 per year.

**Pregnancy Support and Wellness Services: SB 256/HB 343**: This bill would improve the integrity of the state-supported childbirth-only Pregnancy Support Centers by requiring that information presented be medically correct and requiring Department of Health inspections and annual audit reports.

**Employment and Curfew of Minors HB49** The AAUW Florida opposes bills aiming to enable employers to hire 16-year-olds without time or job restrictions (HB49/SB1596), because of the supreme importance of a good education in lifting people out of poverty.

**The Freedom to Learn Act S1414/HB1355** The Freedom to Learn Act would repeal or amend many of the provisions of previously passed legislation prohibiting educational materials related to system racism and "identity politics".

## S1442/H1609 Pregnancy Support Services

Would establish the Florida State Maternity Housing Program within the Department of Health, for resident women and families during the prenatal period if they don't have the resources for housing, i. e. experiencing homelessness. Limit is 8 months including a maximum of 6 weeks postpartum care. Services would also be provided to "encourage economic independence and positive health outcomes."

Staff analyses in the House and Senate reference the affordable housing crisis in Florida and the negative impacts of homelessness on pregnant women and their infants.

If these bills become law, it will still be up to the Department of Health to establish rules regarding client eligibility, adequacy of housing arrangements, and methods for payment or reimbursement for housing.

These bills are moving with bipartisan support, so ask your legislators to vote for them when they reach the floor of the House or Senate.

### H687/S1160 Use of Campaign Funds for Childcare Expenses

These identical bills are very simple: candidates would be able to use campaign funds for childcare expenses that would not have been incurred but for the campaign. The state restricts use of campaign funds for household expenses, so this would constitute an exception.

### We heard from a representative of the national organization VoteMama

(<u>https://www.votemamafoundation.org</u>) which seeks to make it easier for moms to run for office. They petitioned the Federal Election Commission, which approved the use of campaign funds for childcare, but this only applies to federal elections. They have to go state by state to get approval for the use of campaign funds in state and local campaigns.
